#### How does state law apply?

#### Warranty Conditions

Prior to installation, the panels and/or suspension system must be kept clean and dry and not subject to Abnormal Conditions (as specified above). If the panels and/or suspension system are installed in, or subsequent to installation are exposed to Abnormal Conditions or improper maintenance, then the panels and/or suspension system may be damaged. Such damage is not covered by this warranty nor is it the responsibility of Armstrong.

The Ceiling Panels shall not be used to support any other material.

#### WOODWORKS® Ceiling Panels One (1) Year Limited Warranty

Armstrong WoodWorks ceiling panels, WoodWorks ceiling trim, and WoodWorks custom suspension systems are warranted to be free from defects in materials or factory workmanship for one (1) year from the date of installation (except for obvious defects in materials or factory workmanship, of which Armstrong must be notified within 30 days of the date of shipment to the customer). (For WoodWorks ceiling panels installed on standard suspension systems, refer to the relevant grid warranty for Commercial Suspension Systems.)

This limited warranty is subject to further conditions listed below.

#### What does this warranty not cover? See General Warranty Conditions for additional
