The PTC Aztec® Tower Chair<sup>™</sup> is an individual, all plastic rebar chair used to maintain the elevation of rebar in reinforced concrete. The PTC consists of a onepiece base molded from composite material and various height inserts to develop the required cover height. The Aztec® Tower Chair<sup>™</sup> is constructed from USA manufactured materials and will not shatter in cold climates or sag in hot climates.

# APPLICATION

PTC Tower Chair is used for single mat rebar or wire mesh, both layers of double mat rebar or wire mesh, Tilt Wall, as a side form spacer and on-grade when used with a sand plate.
