PRODUCT DESCRIPTION

Sika® Fibermesh®-300, micro-reinforcment system for concrete is made up of 100 percent virgin homopolymer polypropylene firbrillated fibers. Specifically engineered and manufactured in an ISO 9001 certified manufacturing facility for use as concrete reinforcement. Sika® Fibermesh®-300 previously SikaFiber PPF.

USES

Sika® Fibermesh®-300 is a micro fiber that acts mechanically by supporting the aggregate within the concrete with multi-dimentional fiber network and helps to develop a uniform bleed in the concrete system. The fiber does not affect the curing process chemically and it does not absorb water. The Sika® Fibermesh®-300 can be used in all types of concrete applications to control plastic shrinkage and settlement cracking. Typical applications include:

- Residential applications: sidewalks, driveways, decks, curbs
- Stucco
- Shotcrete
- Overlays & toppings
- Roads & pavements
- Tanks & pools
