SAMPLE

SINAK Corporation warrants that LithiumCure 1000 and Sealer SG (The SINAK Traffic Deck System) are of the highest quality as measured by exacting manufacturing standards. When applied in full accordance with written application instructions, the SINAK Traffic Deck System will provide a waterproof barrier within the treated concrete for a minimum period of 20 years from the date of application. The treated area is warranted against damage from water, freeze/thaw, salt, acid rain, hydrostatic pressure, and surface deterioration due to reinforcing steel corrosion. The applied products will not degrade or deteriorate due to ultra-violet exposure. This warranty will remain in effect should the surface be marred or abraded during construction and surface preparation is allowed up to 1/4" amplitude. This warranty is non-prorated and transferable should the property be sold or transferred during the warranty period.

**CONDITIONS**

Concrete treated with the SINAK Traffic Deck System must have a water/cement ratio of 0.50 or less, and must have been mixed, placed, and finished in accordance with guidelines by the ACI (American Concrete Institute) Guide to Concrete Floor and Slab Construction; 302.1R-15. This warranty only covers failures from causes listed above.

Concrete containing any of the following is not covered by this warranty: aggregate considered deleterious as noted in ASTM C33/C33M-16, section 7.3; and "Causes of Floor and Slab Imperfections" in the ACI ) Guide to Concrete Floor and Slab Construction; 302.1R-15, Chapter 13 part 13.6-13.8. Admixtures containing chloride, silicate or water repellants are not covered under this warranty. Chemicals and contaminants introduced by the underlying soil are not covered under this warranty. Improper installation, use or defects associated with preparation materials, or coatings are not covered under this warranty. Damage caused by movement of joints and cracks is not covered under this warranty.

**REMEDY**

RILEM Tube Test for twenty (20) years. In the event of failure of the waterproof barrier or related damage and under the above conditions, SINAK Corporation will provide materials to retreat and/or repair the affected area(s). Retreated/recoated area(s) shall be covered for the remainder of the warranty period. *This is our only warranty. We make no other warranty, express or implied, including merchantability or fitness/or a particular purpose.*
